In my report to the AGM last year. I noted that it had been a challenging year in terms of forming viable leagues given the shifting demographics in the Upper Island. At that time, I wrote that:

... "it is vital that we continue to engage in the process (of reviewing our programs) and, as a district, we will continue to work with our clubs and other soccer partners to reach consensus on how we can better deliver programs that meet the needs of our members".

Thanks to the hard work of Darrin McLeod, his technical committee and dedicated club reps, we have engaged in that process and have seen some exciting new initiatives come to the fore. Working in partnership with Lower Island, we have successfully been granted an Island BC Soccer Premier League franchise and have agreed to the establishment of a tier II Vancouver Island Premier League that will be phased-in starting next year. These and other local initiatives are significant in that they will allow more accessibility for our players to a full spectrum of developmental play and potentially revitalize interest and play at all levels. We will need to continue to work together and with our partners to support these initiatives to ensure their ongoing success.

Creativity and initiative at other levels also continue to maintain league play and development. Again we hosted two successful futsal festivals in both Nanaimo and Comox, but we would still like to see more UI clubs participating. Last spring, UISA and OYS hosted a successful Island Invitational Cup and we worked with Alberni YS in hosting a very dynamic Tenth Annual Mini World Cup. Currently we are looking forward to Campbell Rivers' hosting of the Eleventh Mini World Cup on May 14/15th, dedicated in the memory of Graham Sibley, and to having our teams compete in the 47th edition of the Island Invitational Cup hosted by Lower Island on May 8th. Currently our District continues to be well represented in Coastal and Provincial Cup play and we wish those teams well. Powell River YSA along with UISA has successfully bid to host the U-13 B/G's Provincial B Cup in July and we wish the local organizing committee every success with that venture. Well done!

Again, I would like to thank our hard working executive and our administrator, Courtney Bardonner, on your behalf. Courtney has put in a tremendous amount of work and enthusiasm into her new role and has made our positions as directors much easier as a result. It has been a very real pleasure for me to work with such dedicated and capable people over the years. For their support and work on your behalf and that of our players... and for me, personally.... I am very grateful.

For personal reasons, I will not be seeking re-election to the UI Board. I have very much enjoyed my thirty odd years of involvement as a coach and/or director with local football associations. I hope to continue my involvement in some manner but do feel that it is time now that I step back from the front lines. I hope that you will continue to offer the generous support that you have afforded me over the years to our current and new directors as they continue to work on your behalf.
