- o In an effort to support LTPD and Coach Development, this is the last year that all Head coaches, A and B Cup can participate in Provincial Cup play with only CCS and CCY- all coaches at A and B Cup will now need Soccer for Life. UISA with BC Soccer to offer courses. Information to follow.

Administrators/Schedulers Report - 2012-13 Season

The 2012-13 season saw 31 teams participate in the UISA league:

U12 – 5 boys: AVYSA, CRYSA, CRYSA, CVUSC, CVUSC

U13 – 4 boys: CRYSA, CVUSC, Mid-Isle, HCFC 4 girls: CVUSC, Mid-Isle, HCFC, PRYSA

U14 – 2 boys: AVYSA, PRYSA

3 girls: CRYSA, CVUSC, PRYSA

U15 - 1 boy: Mid-Isle

3 girls: CVUSC, Mid-Isle, PRYSA

U16 – 1 boy: CRYSA

2 girls: CVUSC, PRYSA

U17 – 1 boy: HCFC

2 girls: AVYSA

U18 – 2 boys: CRYSA

1 girl: CRYSA

Teams were distributed between three divisions for play, based on age and ability. Divisions were: U12, U13-15, U16-18. League play ran from September to December and then resumed after Christmas from January to March. Playdowns were in February and March

These divisions allowed competitive play and the opportunity for teams to develop and be challenged. Once in cup play, UISA advanced to become the Island qualifiers in BCSA Provincial B-Cup Championships July 4-7, at U14G (PRYSA Surge), U15G (PRYSA Cobras), U16B (Campbell River Bluebacks) and U17B (Harbour City). The U15G Powell River Cobras will compete in the Coastal Cup Finals, Sunday, May 5 in Richmond.

The 49th Annual Island Invitational Cup is tomorrow, Sunday, April 28, and we will have 12 teams participating.

There were six teams in each division with the exception of the U15G and U16G. These divisions completed one round of play with U15/16 interlocking followed by single-age division play + exhibition games. Then six team divisions completed three rounds of play + exhibition games. League play ran from September to December and then resumed after Christmas from January to March. Playdowns were in February and March.

Once in cup play, three Upper Island teams advanced to become the Island qualifiers in BCSA Provincial A-Cup Championships July 4-7; U16B Riptide and U16G Storm. The Harbour City U13G challenged for A-Cup, and will also compete in the BCSA Provincial A-Cup Championships July 4-7. They, as well as the U16G Storm will compete in the Coastal Cup Finals, Sunday, May 5 in Richmond.

The UISA League was faced with fewer challenges in its formation this season as our member clubs sought more competitive soccer to better support their members abilities to move more effectively through BC Soccer's tiers. The future of the UISA and the VIPL League will continue to be influenced by the changing demographics and needs of individual clubs and players. Hopefully through open communication and the involvement of all clubs, our League will grow to best suit the needs of member clubs.

Finally, the determination of a season structure and dates for league and cup play continue to be a yearly challenge. As BC Soccer plans to review the structure of Cup competitions this next year, changes may occur is this area. UISA also needs to continue to determine at what level teams wish to participate in outside events such as Coastal cups, Provincial play and Island Cup. Member clubs support and participation in the UISA and VIPL leagues and outside events will help to structure league play.
