### **PART 5 Breaches of the Laws of the Game**

This is an abridged version of policy. Please refer to the BC Soccer Discipline Policy and Procedure Guide for more information.

1. Game suspensions will be served starting your very next scheduled game, whether it is league or cup, whichever comes first.
2. Suspensions cannot be sat out in exhibition or tournament games but note that red/yellow cards received in these types of games will be reported and recorded.
3. Games cancelled because of weather conditions, stoppage in the schedule or by forfeiture; do not count as a game sat out.
4. Team officials are advised not to put the names of suspended players on the team list.
5. If a suspended player/team official is also a referee they are not entitled to referee while under suspension.
6. In fact, suspended players or team officials may not participate in any Association sanctioned soccer related activity that includes administering, coaching, managing, playing or officiating.
7. For more concise information please read the B.C.S.A. Rules and Regulations and Discipline Policy.
8. Suspensions not completed in one season will carry over to the first game(s) of the following season.
9. Youth players moving up to Senior who have discipline carrying over will sit out their first game(s) in Senior.

#### **RIGHT TO APPEAL:**

1. Appeals to the Association (BC Soccer #250 – 3410 Lougheed Hwy, Vancouver BC, V5M 2A4) must be filed with the Executive Director of the Association within seven (7) working days after the issuance of the Discipline Committee's decision.
2. Appeals must be in writing stating the grounds upon which the appeal is lodged.
3. A concise submission stating the By-Laws, Rule or Regulation that has been contravened and setting out clearly in what respect the decision is alleged to be wrong.
4. The appeal shall be signed by the affiliated team coach, manager, registered player or official.
5. The fee of \$500.00 (made payable to BC Soccer) shall accompany the appeal when filed with the Association.

Note: The Discipline Committee's decision shall remain in effect pending the result of the appeal.

#### **PARTICIPATING WHILE UNDER SUSPENSION:**

- Any player who knowingly participates in a game while under suspension shall be assessed a 6 months suspension in addition to the original suspension levied.
- Any team official who acts in a manner that may be deemed to be coaching or managing while under suspension shall be assessed a 6 months suspension in addition to the original suspension levied.
- Any player or team official under suspension, if attending a game as a spectator, behaves in a manner that brings disrepute to the game shall be subject to a further 6 months suspension in addition to the original suspension levied.
